#### **Volume Charge:**

First 15,000 gallons used per month - \$5.14 per 1,000 gallons

Over 15,000 gallons used per month - \$4.37 per 1,000 gallons

**Late Payment Fee** - All bills are assessed a 1% late payment fee, per month, if paid after the due date. Properly applied penalties cannot be waived.

**Budget Billing** – Budget billing is available to customers, although certain eligibility requirements apply. Please call for details.

**Utility Returned Item Fee** – When the bank cannot honor a customer payment, (due to insufficient funds, account closed, payment stopped, etc.) the customer shall be billed the amount of the payment, plus **\$25.00** and any additional charges added by the bank.

**Customer Charge** – A minimum monthly fixed charge designed to recover the costs of providing safe, reliable electric and water services. This includes the cost of owning, operating and maintaining meters, poles, wires, substations, water towers, wells, and other electric and water equipment.

**CITY OF ALGOMA SEWER RATES**

**Effective: 12/29/21**

Authorized by: Algoma City Council

Sewer is a City service which is billed and collected by the Algoma Utilities for the convenience of the City of Algoma. Sewer collections are forwarded to the City.

**GENERAL SERVICE – METERED**

**Monthly Customer Charge:**

5/8-inch meter -	\$28.37	2-inch meter -	\$139.50
1-inch meter -	\$47.29	3-inch meter -	\$255.34
1 ½-inch meter -	\$88.66	4-inch meter -	\$410.20

**Volume Charge:**

- Based on water usage - \$11.70 per 1,000 gallons
- Consumption is billed based on water usage and is shown in hundreds of gallons on bill.

Sewer volume charge is based on water consumption as directed by the City of Algoma.

Sewer user fee is levied by the City of Algoma through Ordinance.
